### **NEIGHBOURHOOD REFERENCE GROUP**

The NRG is a collaborative alliance consisting of community members from all areas surrounding the site, including members of local organisations, and representatives from the EPA Victoria, the City of Ballarat Council, and CVLX.

The most recent NRG meeting was held on 25<sup>th</sup> August 2020 via zoom due to COVID-19 restrictions. The meeting provided members with an update on CVLX operations, environmental matters including the two Pollution Abatement Notices (PAN) relating to operational improvements and processes initiated by CVLX management, and the community grants program.

The next NRG meeting is scheduled on Tuesday 24<sup>th</sup> November 2020 at the local Miners Rest Community Hall. If we are unable to go ahead with this meeting, in person due to COVID-19 restrictions, the meeting will be held again via zoom.

### THE RESULTS

CVLX continues to attract strong prices, with the recent store sale being reported as the "dearest sale ever" for Ballarat. CVLX congratulates the agents and their vendors on achieving these great results and it is fantastic to see the positive difference the facility is making to the Victorian livestock industry.

At a recent special sale held at CVLX on 23<sup>rd</sup> October 2020, Ayrvale Angus Final Dispersal Sale also saw a fantastic result where quality genetics were on offer by vendor Richard White. The sale attracted some intense bidding with just over 50% of the bids coming from the Stocklive platform online and 84% of the lots going to online buyers.

CVLX has seen a monumental shift during COVID-19 to a materially increased level of buyer participation and activity via the StockLive online platform utilised at CVLX sales.

### **COVID-19 UPDATE**

Sale days have looked a little different lately as we continue to operate within prescribed government guidelines. Anyone attending site has been required to wear a facemask and it was pleasing to see the auctioneers and agents led the way in embracing these changes.

RLX will always prioritise public health and monitor the most current State and Federal Government advice on the COVID-19 situation and provide regular communications regarding any further changes to onsite procedures when and where required.

CVLX management would like to extend our thanks to all the CVLX clients and the broader community for their cooperation with these important matters as we continue to work hard to maintain an active and transparent marketplace in these unprecedented times.





### **ENVIRONMENTAL UPDATE**

CVLX has successfully met the commitments made in both EPA PAN's. This included the following projects, completed by local contractors:

- A full-scale sheep yard gate modification project that allows for better access for larger cleaning equipment
- Planting of approximately 2,200 native saplings and 50 mature gum trees around the site. A further 2,100 trees will be planted as part of Stage Two works commencing early next year. This vegetation planting is in addition to the Upper Emu Creek Landcare Network's 'Trees for Change Program', proudly sponsored by the CVLX Community Grants Program

In the May 2020 CVLX Newsletter, CVLX advised consideration was being given to trialling a deodorising system to neutralise fugitive odour emissions from the site. Following consultation with the NRG and feedback provided by the EPA and Ballarat Council, the decision was made not to progress with the trial, due to further investigations occurring relating to the use of this technology.

A revised Environmental Improvement Plan and a revised Odour Management Plan have been submitted to the EPA for review prior to submission to the City of Ballarat Council for endorsement. These documents will be published on the CVLX website once approved.

The team at CVLX is always looking at more ways to improve our operational efficiencies and to that end, a recently trialled modified washdown process has provided a material reduction in water usage and reduced the time taken to complete each washdown, when required.
