## 1. PURPOSE

RLX Operating Company Pty Limited (RLX) holds an Environment Protection Licence with the NSW Environment Protection Authority (EPA) for Central Tablelands Livestock Exchange (CTLX). As per the *Protection of the Environment Operations Act 1997* (the POEO Act), the holder of an Environment Protection Licence must prepare, keep, test and implement a pollution incident response management plan (PIRMP) that complies with Part 5.7A of the POEO Act in relation to the activity to which the licence relates.

If a pollution incident occurs in the course of an activity so that material harm to the environment (within the meaning of section 147 of the POEO Act) is caused or threatened, the person carrying out the activity must immediately implement this plan in relation to the activity required by Part 5.7A of the POEO Act.

A copy of this plan must be kept at the licensed premises, or where the activity takes place in the case of mobile plant licences, and be made available on request by an authorised EPA officer and to any person who is responsible for implementing this plan.

Parts of the plan must also be available either on a publicly accessible website, or if there is no such website, by providing a copy of the plan to any person who makes a written request. The sections of the plan that are required to be publicly available are set out in section 74 of the Protection of the Environment Operations (General) Regulation 2022.

## 2. SCOPE

This PIRMP covers the CTLX site at 4860 Mid Western Highway, Carcoar NSW 2791 which operates under Environmental Protection Licence No. 12630.

## 3. DEFINITIONS

**Pollution incident** means an incident or set of circumstances during or as a consequence of which there is or is likely to be a leak, spill or other escape or deposit of a substance, as a result of which pollution has occurred, is occurring or is likely to occur. It includes an incident or set of circumstances in which a substance has been placed or disposed of on premises, but it does not include an incident or set of circumstances involving only the emission of any noise.

A pollution incident is required to be notified if there is a risk of 'material harm to the environment', which is defined in section 147 of the POEO Act as:

- a) Harm to the environment is material if:
  - i. It involves actual or potential harm to the health or safety of human beings or to ecosystems that is not trivial, or
  - ii. It results in actual or potential loss or property damage of an amount in aggregate, exceeding \$10,000 (or such other amount as is prescribed by the regulations), and
- b) Loss, including the reasonable costs and expenses that would be incurred in taking all reasonable and practicable measures to prevent, mitigate or make good harm to the environment.

Notification is required even where 'harm to the environment is caused only in the premises where the pollution incident occurs', as specified in 147(2).




Figure 1 – Premises neighbour notification map

## 8. DESCRIPTION OF LIKELIHOOD OF HAZARDS

POTENTIAL HAZARD	LIKELIHOOD
Surface run off from effluent irrigation to surface waters	Medium
Failure to contain effluent treatment system water	Low
Failure to contain sheep & cattle waste materials	Low
Contamination of surface water wetland	Low
Chemical leak of spill contaminating the environment and / or injury to personnel	Low
Fuel leak or spill contaminating the environment and / or injury to personnel	Low
Fire – Bushfire destroying infrastructure and / or injury to personnel	Low
Fire – Combustible hay destroying infrastructure and / or injury to personnel	Low
Fire – Kitchen fire destroying infrastructure and / or injury to personnel	Low
Fire – Vehicle Fire destroying infrastructure and / or injury to personnel	Low
Gas – uncontrolled release of gas destroying infrastructure and / or injury to personnel	Low

## 9. RE-EMPTIVE ACTIONS TO BE TAKEN

Specific pre-emptive actions for the corresponding hazards identified in the earlier section:

- a) Provision of a dedicated chemical storage area with bunding and spill containment kits.
- b) Provision of dedicated fuel storage area with bunding and spill containment kits.
- c) The property boundary fence to be kept mown and clear of debris.
- d) Regular monitoring of stored hay / fodder for heat.
- e) Ensure the kitchen has sufficient appropriate fire extinguisher and fire blanket.
- f) Ensure fire extinguishers are located at strategic points within the site.
- g) Smell check for gas leaks
- h) Ensure sheep and cattle waste area is appropriately managed in accordance with the solids management procedure.
- i) Regular monitoring of effluent treatment system in accordance with the effluent management procedure.
- j) Effluent irrigation to be performed in accordance with the effluent management procedure.
- k) Quarterly sampling and testing of piezometers and effluent system water.

In general:

- c) Staff induction prior to or at commencement of employment
- d) Regular staff meetings
- e) Use of Safety Data Sheets (SDS) information
- f) Saleyard advisory meetings
- g) Annual internal environmental compliance audit

## 11. SAFETY EQUIPMENT

Safety equipment provided on the site includes:

- Spill kits
- Fire extinguishers
- Fire blankets
- First aid equipment
- SDS's to be kept in the maintenance and administration office
- Dangerous goods manifest to be kept in the maintenance shed and administration building, where required.
- PPE to be available in the maintenance shed and administration building

## 12. COMMUNICATING WITH NEIGHBOURS AND THE LOCAL COMMUNITY

The nature and type of potential pollutant incidents for this site are limited, however if an environmental incident on site is likely to impact neighbouring businesses or the local community, surrounding neighbours will usually be contacted either by phone, SMS, email, door knocking or through information left at the place of residence by a CTLX representative to notify them of a situation.

Communication methods will be used on a case-by-case basis, but in all situations, CTLX will attempt to notify those neighbours likely to be directly affected as soon as possible.

Ongoing communications with the neighbouring businesses/residents will be maintained until such time as the incident is rectified.

Should a pollution incident occur, it must be immediately reported to the Business Manager (or Assistant Manager in their absence) who will assess the incident and the likely impact on persons on the premises. If appropriate, the Business Manager (or Assistant Manager) shall initiate a site evacuation utilising the public address system.




Figure 2 – Premises overview



Figure 3 – Chemical Storage Plan





Figure 4 - Safety and pollution response equipment location

## **16. COORDINATING WITH PERSONS AND AUTHORITIES**

All staff must notify the Business Manager, immediately after the person becomes aware of a pollution incident. The Business Manager will notify the General Manager in accordance with the RLX Hazard and Incident Reporting Procedure.

If the pollution incident presents a risk of 'material harm to the environment' the General Manager (or delegate) will immediately notify the relevant Authorities after being notified or otherwise becoming aware of the pollution incident.

The following information shall also be provided to the relevant Authorities:

- a) The time, date, nature, duration and location of the incident,
- b) The location of the place where pollution is occurring or is likely to occur,
- c) The nature, the estimated quantity or volume and the concentration of any pollutants involved, if known,
- d) The circumstances in which the incident occurred (including the cause of the incident, if known),
- e) The action taken or proposed to be taken to deal with the incident and any resulting pollution or threatened pollution, if known,
- f) Other information prescribed by the regulations.

## **17. STAFF TRAINING**

All staff affected by the content of this document will receive instruction or explanation on the relevant sections or requirements of the document.



## 18. TESTING AND UPDATING OF THE PIRMP

The PIRMP shall be tested once every 12 months and within one month of any pollution incident occurring. The objective of testing is to assess whether the information included in the PIRMP is accurate, current and is capable of being implemented in a workable and effective manner.

The routine testing will be performed as a desktop exercise and the name of the person(s) carrying out the test will be recorded in the PIRMP test report below. If the PIRMP is updated the date and details on amendments to the plan shall also be recorded.
